### The Modules

Once your booking is confirmed, you will receive access to the Online Modules 2 weeks prior to your Live Webinar booked date. The Modules are pre-recorded lectures delivered by our expert trainers, and can be completed in your own time. They each include a quiz designed to reinforce your learning.

### Approved Clinician Status

This course is for mental health professionals in England renewing their Approved Clinician approval. Please contact your local Approving Panel for more information. Please note that attendance at the Live Webinar is only part of the renewal process.

### Accreditation

This course has been approved by the Department of Health and Social Care's National Reference Group (NRG) representing all four National Approval Panels in England, and is awarded 6 CPD hours subject to your peer group approval and in line with RCPsych guidance.
